

CONTRACTUAL RELATIONSHIP

- 1.1 The Terms and Conditions ("Terms") constitute an Agreement between you, an individual, ("Users" or "You") in which Eihal undergoes commercial activities, of mobile applications, websites, content, products and services ("Services") made available by Eihal.
- 1.2 Your access and use of the Services constitute your agreement to be bound by these Terms, which establishes a contractual relationship between You and Eihal. By using the Services, You consent to be bound by these Terms and must check the "I accept" box herein-below stating your acceptance of these Terms.
- 1.3 By using the Services, You concur that You have the full capacity to enter into a legally binding agreement, and to be held accountable in case You violate the Terms. Otherwise, You understand that Eihal may terminate or hinder your use of the Services.
- 1.4 You understand and acknowledge that Eihal may amend the Terms related to Services from time to time. Eihal shall notify You of such changes to the Terms and Your acceptance to the amended Terms is required to continue using the Services.
- 1.5 Users agree that Eihal can contact them by text message or telephone calls on the phone numbers they provide at user registrations including for internal marketing purposes of Eihal. This will not constitute disclosure or share of any of your personal identifiable information.
- 1.6 By accessing or using any part of the Services, You agree that You have read, understood and agreed to be bound by these Terms, as well as any additional available guidelines, policies, or rules as applicable to the Eihal and its Services, including but not limited to, the Eihal Privacy Policy.

IF YOU DO NOT AGREE TO BE BOUND BY THESE TERMS AND TO FOLLOW ALL APPLICABLE LAWS, GUIDELINES AND POLICIES, DO NOT ACCESS OR USE THE SERVICES.

2. SERVICES

2.1 This constitutes a technology platform that allows users of Eihal website and application to search and make referrals, as well as seek remote medical consultation and diagnostics through Eihal's Doctors.

WE DO NOT OFFER MEDICAL ADVICE, DIAGNOSIS OR TREATMENT. WE DO NOT ENDORSE NOR RECOMMEND YOU A SPECIFIC PROVIDER. WE DO NOT -AND DO NOT INTEND TO- PRACTICE MEDICINE. WE ONLY HELP YOU SEARCH, BOOK AND MAKE REFERRALS TO OTHER DOCTORS. THEREFORE, IT IS CRUCIAL THAT YOU EMPLOY THE SAME CAUTIOUSNESS AND PRUDENCE YOU WOULD HAVE EMPLOYED WITHOUT USING OUR SERVICES.

3. LICENSE AND INTELECTUAL PROPERTY

3.1 All licenses and Intellectual Properties including but not limited to trademarks and logo are solely owned to Eihal. You may not carry any act that may constitute as an abuse or infringement of the Eihal copyright including false marketing or misleading advertisement, or copy of the Eihal licenses or trademark under any circumstance. By using our Services, Eihal hereby grants You a limited, revocable, non-exclusive, non-sub licensable, right to: (i) access, upload and use our mobile application or website for the sole purpose of using our Services; and (ii) access and use information and materials provided, made available or otherwise found on our Content.

3.2 This license is:

- Not intended to be sub-assigned, sold, rented, leased, exported, imported, distributed, transferred or otherwise granted to third parties.
- Not intended for commercial use. You are only licensed to use our Services for personal, non-lucrative, non-commercial use.

4. OUR CONTENT

- 5.1 Eihal's platform may contain links to third-parties' websites, advertisers, or services that are not owned by Eihal. You acknowledge and understand that such content may be subject to different terms of use and privacy policies than Eihal's. Therefore, the present Terms do not apply to You when accessing or using third parties' services.
- 5.2 If You access third parties' websites from Eihal's website, You do so on your own liability and You consent to releasing Eihal from any and all liability arising out of such use.

6. USE OF THE SERVICES

6.1 User Accounts

- 6.1.1 To create a user account, You will submit to Eihal personal information, such as your name, address, mobile phone number and e-mail. You agree to grant Eihal the right to share such personal information with our registered Providers as per our contractual agreement with them;
- Your personal data must be accurate, complete and updated at all times. Failing to do so, You acknowledge that Eihal has the right to terminate or hinder your use of the Services.
- You must choose a password to access your user account and must keep it confidential at all times.
- You understand that you will be responsible for any actions/activities made on your user account by unauthorized third parties. You must notify us if You strongly believe your account has been hacked.
- Under no circumstances should You respond to a request for your password, particularly a request from someone claiming to be an employee of Eihal.
- You shall not authorize, assign or transfer your user account to third parties.

- You understand that You will be denied access to your account if you failed to enter your password for 2 consecutive times.
- You agree and consent to the Services provided by Eihal may including remote consultation and agree to sign the consent form relating to such Services where provided.
- 8.1.2 You agree to provide Eihal with the essential information required in order to use the Services. Such personal information shall be private and confidential and shall be subject to Eihal's Privacy Policy. Eihal is required by law to maintain the privacy and security of the Users' protected health information. Eihal and its affiliates consider the privacy of the health information to be one of the most important elements in the relationship with the Users. Eihal's responsibility to maintain the confidentiality of the health information is one that Eihal takes very seriously.
- 8.1.3 By accessing and using the Services, You consent to using your email address to send You service-related, change of features or special offers notices including any notices required by law, in lieu of communication by postal mail.

8.2 User Requirements

8.2.1 You are only eligible to access and use our Services if you are at least 18 years of age.

8.3 User Provided Content

- 11.2 The refund will be made on the same payment method, if applicable.

USERS SHALL NOT BE ENTITLED TO A REFUND FOR THE CONSULTATION FEES AND ANY EXPENSES MADE ALONG THE WAY IN THE EVENT YOU ARE UNSATISFIED WITH THE MEDICAL EXPERIENCE OR PROVIDER.

12. DISCLAIMER AND LIMITATION OF LABILITY

- 12.1 Even though we employ measures related to the verification of the Providers (all Providers must submit licenses, permits and certificates required by Law to practice medicine), Eihal does not guarantee that its content is always free of error, complete, accurate or updated.
- 12.2 Eihal will assume no liability for damages caused to You including and without limitation, direct, indirect, special, consequential, punitive or incidental damages, arising out of, or in connection with any of the following acts committed by Providers:
- The failure to deliver proper bedside manners;
- Unprofessional, unethical or dishonorable conduct;
- Wrong or delayed diagnosis of a medical condition;
- Incorrect treatment, delayed treatment, or no treatment at all;
- Medical malpractice or negligence;
- The cancellation of the appointment, the lateness of the Provider, or the no-show at all at the examination appointment.

YOU UNDERSTAND AND ACKNOWLEDGE THAT EIHAL WILL NOT BE HELD ACCOUNTABLE NOR LIABLE FOR ANY DAMAGES, DEATH, INJURIES, CONTRACTED ILLNESS, LOSSES, COSTS OR EXPENSES OF WHATEVER NATURE CAUSED BY THE PROVIDER.

13. FORCE MAJEURE

13.1 Eihal will not be held liable for the failure to perform its obligations under these Terms due the occurrence of any event beyond its reasonable control, including, without limitation, fire, terrorism, natural disaster, pandemics, war, boycott, labour disturbance, Internet or communications outage or interruption of service or any other instances which cannot be foreseen, prevented or controlled.

14. LIMITATION OF LIABILITY

15.1 These Terms shall be governed under the laws of the Kingdom of Saudi Arabia. Any dispute arises in relation with these Terms, shall be settled and heard before the competent courts in Riyadh, Kingdom of Saudi Arabia.

16. COMPLIANCE WITH LOCAL LAWS
